With reference to the **IFB No: AHIDMS/JICA/P&C/Equipment/MRI/2024/04/REBID** invited for Supply and Installation and Commissioning of MRI 3T for Assam Medical College and Hospital, Dibrugarh, Assam. Under Assam Health System Strengthening Project (AHSSP) funded by JICA.

The following corrigendum in the subject Tender issued is hereby authorized:-

As per **Point No. 7 of the Exchange of Notes dated 19th March 2022** between the Government of India and the Government of Japan for this project, there will be no exemption of import duties or any other tax exemption for the Contractor's equipment, including essential spare parts. Therefore, Paragraph 1 of **BDS 14.9** will not apply.

The Employer has decided to keep the GST (Goods & Services Tax) component separate from the bid price for evaluation purposes and to make it easier to identify the tax portion while raising disbursement claims from JICA.

Accordingly, ITB 14.9 will now read as follows: **"There is no exemption or reimbursement of any taxes and duties for this project. The Bidder must include all duties, taxes (except GST) and other levies payable under the Contract in the bid price. In case of any change in GST rate, necessary adjustments will be made in the invoices submitted after the date of such revision. All item rates should be quoted exclusive of GST. GST will be added separately and paid at the prevailing rate over and above the quoted rate as shown in the Price Bid, against proof of payment."**

In addition to the above, as per Point No. 7 of the Exchange of Notes dated 19th March 2022, between Government of INDIA and Government there is no any exemption of taxes, so Section-VII-17 and G.C-17.1 are deleted in line with BDS 14.9.
