UNDER A WORLD BANK FINANCED HEALTH SECTOR PROJECT**

1. The 'Assam Health Infrastructure Development & Management Society' (AHIDMS) under the Medical Education & Research Department (MERD), Govt. of Assam (GoA) has been tasked to implement the 'Assam Secondary Healthcare System Reforms Project' (ASHSRP) taken up by the GoA with proposed financing from the World Bank. The project, to be implemented over six years, *inter alia* aims to improve the district level healthcare services in Assam by improving quality, access and management capacity in selected district hospitals.

2. The AHIDMS invites applications for the following purely temporary contractual positions for the Project Management Unit (PMU) of ASHSRP. The shortlisted candidates shall have to bring all the original certificates/testimonials along with a set of self-attested copies of the same, for the interview/test. The Originals of certificates/documents will be returned after corroboration with the self-attested copies of the same. If at any stage, the information furnished in the application or supporting documents is found to be forged/ misrepresented/ incomplete/ false, the candidature shall be liable for cancellation and penal action as per law.
